## CHA Testifies on Cal/OSHA Workplace Violence Prevention Regulations

On Dec. 17, CHA testified before the California Occupational Safety and Health Standards Board about Cal/OSHA's proposed workplace violence prevention regulations for health care employers. CHA's testimony acknowledged the importance of violence prevention for employee and patient safety, and highlighted three main areas of concern with the proposal.

- **First**, CHA urged that Cal/OSHA focus on process, not outcome – in other words, require health care employers to have an effective program, and not assume that an incidence of violence indicates an inadequate plan, thus penalizing the employer.
- **Second**, CHA requested confirmation that the health care employer retains the discretion to determine appropriate staffing levels and that dedicated security staff is not required.
- **Third**, CHA is concerned about the unreasonably short timeframe for health care employers to develop and implement training required by the proposed regulation. Cal/OSHA has stated that it plans to release the final regulation in July, and expects employers to have developed their plans and trained all employees accordingly by Oct. 1. CHA emphasized that if the goal is effective training, employers should be provided sufficient time to develop it and roll it out.

## Joint Commission will emphasize management of clinical alarms starting Jan. 1, 2016

In 2013, the Joint Commission issued a Sentinel Event Alert on alarm management to offer information and guidance on managing the risks associated with clinical alarms. In January 2014, The Joint Commission implemented phase I of National Patient Safety Goal 06.01.01 (NPSG) with requirements to establish clinical alarms as an organizational priority.

**Phase II of NPSG 06.01.01 went into effect January 1, 2016. Hospitals and critical access hospitals need to establish and implement policies and procedures for managing clinical alarms.**

To meet elements of performance for phase II of NPSG 06.01.01, hospitals will be expected to:

1. Develop and implement specific components of policies and procedures that address at minimum:

- Clinically appropriate settings
- When alarms can be disabled
- When parameters can be changed
- Who can set and who can change parameters and who can set to “off”
- Monitoring and response expectations
- Checking individual alarm signals for accurate settings, proper operation, and detectability

2. Educate those in the organization about alarm system management for which they are responsible.

## **CMS issues memo on new infection control project**

The Centers for Medicare & Medicaid Services (CMS) recently issued a Survey and Certification Memo announcing a three year pilot project to improve the assessment of infection control and prevention regulations in hospitals and nursing homes. CMS will be performing educational pilot surveys to provide nursing homes and hospitals with guidance on improving infection prevention. In fiscal year 2016, a survey process and surveyors infection control worksheet will be piloted in nursing homes. In 2017, the pilot surveys will extend to hospitals.

Good news is there will be no citations issued by their findings just strictly education, but CMS said that if an immediate jeopardy deficiency is noted, a referral will be made to the CMS Regional Office (O\_o)
